Dr. Price presented certificates to each board member in honor of School Board Recognition Week – February 18th -22nd.

Carter moved, seconded by Heninger, to enter into a cooperative agreement with the Community & Youth Involved Center, Inc., and the Three Rivers Co-op LLC., for the purpose of a commitment to support the GOLD (Great Opportunities for Learning and Developing) Program for the duration of the grant. All voted aye. Motion carried. The AdvancEd Committee consisting of Jen Milliken, Kim Doherty and Shirley Swanson updated the board on the AdvancEd activity. The MS/HS update was read by Superintendent Price. Principal Terri Mehlhaff updated the board on activities in the elementary.

Cronin moved, seconded by Carter, to deny Open Enrollment applications #571819032 and #571819036. All voted aye. Motion carried.

Carter moved, seconded by Roggow, to approve the resignation of Sarah Eddie as MS/HS Paraprofessional effective January 31, 2019. All voted aye. Motion carried.

Heninger moved, seconded by Carter, to approve the resignation of Krystal Murphy as SPED Behavior Specialist Paraprofessional effective January 24, 2019. All voted aye. Motion carried.

Cronin moved, seconded by Roggow, to authorize Business Manager to offer Bruce Bresee a Letter of Intent as MS/HS Paraprofessional in the amount of \$13.50 per hour and Assistant 6-12 Track Coach in the amount of \$3,832.00 effective 2018-2019 school year. All voted aye. Motion carried.
